2 Business Results

Results of Operations for the 6 months ended June 30, 2024.

- Ordinary income totaled 68.9 billion yen, mainly consist with followings.
 - Interest income totaled 41.0 billion yen.
 - Fees and commissions totaled 10.1 billion yen.
 - Trading income totaled 1.2 billion yen.
 - Other ordinary income totaled 15.6 billion yen
 - Other income totaled 0.7 billion yen.
- Ordinary expenses totaled 54.4 billion yen, mainly consist with followings.
 - Interest expenses totaled 40.2 billion yen.
 - Fees and commissions paid totaled 1.7 billion yen.
 - General and administrative expenses totaled 11.3 billion yen.
 - Other expenses totaled 1.0 billion yen.
- Ordinary profit was 14.4 billion yen.
- Income before income taxes (including extraordinary gain and loss) was 14.4 billion yen.
- Net income was 9.9 billion yen.

Assets, liabilities and net assets were as follows;

- As of June 30, 2024, total assets were 5,450.3 billion yen, mainly consist with followings.
 - Cash and deposits to other banks (due from banks) were 2,459.6 billion yen.
 - Receivables under resale agreements were 457.3 billion yen.
 - Loans and bills discounted were 674.2 billion yen.
 - Other assets were 503.2 billion yen, mainly consist with Derivatives other than for trading-assets.
 - Head office and branch accounts (assets) totaled 995.1 billion yen.
- As of June 30, 2024, total liabilities were 5,438.0 billion yen, mainly consist with followings.
 - Deposits were 2,339.1 billion yen.
 - Foreign exchanges were 52.7 billion yen.
 - Other liabilities were 496.6 billion yen, mainly consist with Derivatives other than for trading-liabilities.
 - Head office and branch accounts (liabilities) were 2,193.4 billion yen.
- As of June 30, 2024, total net assets were 12.2 billion yen. 16.5 billion yen of undistributed profits was remitted to the head office in March 2024.

Accounting Policies

1. Standard for valuation of trading assets and trading liabilities / booking of income and losses for trading purposes transaction

Transactions for trading purposes, such as seeking gains arising from short-term changes in interest rates, foreign exchange rates, or securities prices and other market related indices or from variation among markets (hereinafter referred to as "Trading Purposes"), are included in "Trading assets" or "Trading liabilities" on the balance sheet on a trade date basis. Income and Expenses on trading-purpose transactions are recognized on a trading date basis, and recorded as "Trading income" and "Trading losses".

Securities and monetary claims purchased for trading purposes are stated at the interim fiscal year-end market value, and financial derivatives such as swaps, futures and options are stated at amounts that would be settled if the transactions were terminated at the interim fiscal year-end.

"Trading income" and "Trading losses" include interest received or paid during the interim fiscal year. The year-on-year valuation differences of securities and money claims are also recorded in the above-mentioned accounts. As for the derivatives, assuming that the settlement will be made in cash, the year-on-year valuation differences are also recorded in the above-mentioned accounts.

2. Standard and method for valuation of AFS securities

AFS securities that have market prices are carried at their balance sheet date market prices (cost of securities sold is calculated using primarily the moving-average method). Net unrealized gains/losses on AFS securities, net of income taxes, are included in "Net assets".

3. Standard and method for valuation of derivative transaction

Derivative transactions (excluding those for trading purposes) are carried at fair value.

4. Depreciation method for fixed assets

(1) Tangible fixed assets

Tangible fixed assets are depreciated using the declining-balance method (with the exception of building facilities acquired on or after April 1, 2016, for which the straight-line had been applied).

The estimated useful lives are as follows:

Buildings:	10 to 15 years
Others:	3 to 8 years

(2) Intangible fixed assets

Intangible fixed assets are depreciated using the straight-line method. Capitalized software for internal use is depreciated over its estimated useful life (5 years).

5. Standard for the translation into Japanese yen

Assets and liabilities denominated in foreign currencies are translated into Japanese yen at the exchange rate prevailing at the balance sheet date.

6. Standard for Allowance

(1) Allowance for loan losses

Allowance for loan losses is provided as detailed below in accordance with the internal standards for write-offs and provisioning.

For claims on borrowers that have entered into bankruptcy, special liquidation proceedings or similar legal proceedings ("bankrupt borrowers") or borrowers that are not legally or formally insolvent but are regarded as substantially in the same situation ("effectively bankrupt borrowers"), an allowance is provided based on the amount of claims, after the write-off stated in the additional paragraph below, net of the expected amount of recoveries from collateral and guarantees. For claims on borrowers that are not currently bankrupt but are perceived to have a high risk of falling into bankruptcy, an allowance is provided in the amount deemed necessary based on an overall solvency assessment of the claims, net of the expected amount of recoveries from collateral and guarantees. For other claims, an allowance is provided based on the expected loan-loss ratio assigned to each risk rating.

Responsible divisions for Self-Assessment and Front office mutually conduct assessment of all claims in accordance with the internal rules for self-assessment of assets. The allowance is provided based on the results of these assessments.

(2) Provision for bonuses

Provision for bonuses is reported in preparation for the payment of bonuses to the employees at the amount estimated for the payment of bonuses to the employees during the interim fiscal year.

7. Method for hedge accounting

The exceptional method is applied to certain interest rate swaps that meet the criteria for the exceptional treatments. No assessment is performed for hedge effectiveness of qualifying interest rate swaps accounted for by the exceptional treatments, as it is ascertained that the criteria for the exceptional treatments are continuously met.

Notes to Interim Balance Sheet

1. For securities held as collateral under “receivables under resale agreements” and “derivative transactions” which can be sold or pledged without restrictions, 546,327 million yen were pledged and there was no security amount held by Citibank, N.A., Tokyo Branch at the interim fiscal year-end.
2. The followings are the claims under the Banking Act and the Act on Emergency Measures for the Rehabilitation of the Financial Functions. Those claims are recorded in the Balance Sheet accounts of Corporate Bonds in “Securities” (limited to the Corporate Bonds issued by private placement of securities (Article 2, paragraph (3) of the Financial Instruments and Exchange Act)), “Loans and bills discounted”, “Foreign exchanges”, accrued interest and provisional payment in the “Other Assets”, and Customer's liabilities for acceptances and guarantees. There is not applicable balance at the interim fiscal year-end.

3. “Bankrupt and quasi-bankrupt claims” are claims against a debtor who has fallen into the situation such as commencement of bankruptcy proceedings, commencement of reorganization proceedings, and commencement of rehabilitation proceedings, and other similar claims.
4. “Doubtful claim” is a claim that is unlikely to recover the principal of the claim in accordance with the contract and to receive interest, and is not considered to be a Bankrupt or quasi-bankrupt claims thereto, although the debtor has not yet reached a state of bankruptcy, but its financial condition and operating results have deteriorated.
5. “Past due loans (3 months or more)” are loans of which the payment of principal or interest is past due for three months or more, excluding “Bankrupt and quasi-bankrupt claims” and “Doubtful claim”.
6. “Restructured loans” are loans of which terms and conditions have been amended in favor of the borrowers (e.g. reduction of the original interest rate, deferral of interest payments, extension of principal repayments or debt forgiveness) in order to support the borrowers' recovery from financial difficulties, excluding “Bankrupt and quasi-bankrupt claims”, “Doubtful claim” and “Past due loans (3 months or more)”.
The amount of the claim is the amount before the appropriate allowance.
7. Bills discounted are treated as financial transactions in accordance with JICPA Industry Audit Committee Report No.24. Citibank, N.A., Tokyo Branch has rights to sell or pledge bank acceptance bought, commercial bills discounted, documentary bills and foreign bills bought etc. without restrictions. The total face value was 9,851 million yen.
8. AFS securities of 7,073 million yen were pledged as collateral for settlements of FX transactions. In addition, other assets include other guarantee deposits of 16,435 million yen.
9. Overdraft facilities and commitment line contracts on loans are agreements to lend to customers up to a prescribed amount, as long as there is no violation of any condition established in the contracts.
The amount of unused commitments was 475,390 million yen and the amount of those with remaining period within one year was 245,353 million yen.
Since many of these commitments are expected to expire without being drawn upon, the total amount of unused commitments does not necessarily represent actual future cash flow requirements. Many of these commitments include clauses under which we can reject an application from customers or reduce the contract amounts in the event that economic conditions change, we need to secure claims, or other events occur. In addition, we may request the customers to pledge collateral such as premises and securities at the time of the contracts, and take necessary measures such as monitoring customers' financial positions, revising contracts when need arises and securing claims after contracts are made on a periodic basis.
10. Accumulated depreciation on tangible fixed assets: 26 million yen.

(*2) Derivatives included in "Trading assets", "Trading liabilities", "Other assets" and "Other liabilities" are shown together. Negative amount indicates in case of liabilities exceeding the assets.

1. Fair Value Measurement

The fair values of financial instruments are classified as the following fair value hierarchy based on the observability and materiality of the inputs adopted for fair value measurement.

Level 1: The fair values calculated based on the market price (unadjusted) in an active market for identical financial instruments.

Level 2: The fair values calculated using direct or indirect observable inputs other than Level 1 inputs

Level 3: The fair values calculated using one or more significant unobserved inputs

In case of multiple inputs with a significant impact on the fair value measurement, the fair value is classified to the level that has the lowest priority in the fair value calculation among the levels to which each input belongs.

(Notes) Description of the valuation techniques and inputs used to measure fair value

(Assets)

(1) Cash and due from banks

For due from banks without maturity, the carrying amount is presented as the fair value, as the fair value approximates such carrying amount. For due from banks with maturity, fair value is determined as present value of total future cash flows, discounted by interest rate that would be applied to new acceptances. Total future cash flows are contractual payment of principal and interest. For due from banks with short remaining period (within 1 year), the carrying amount is presented as the fair value, as the fair value approximates such carrying amount. They are classified into Level 2.

- (2) Receivables under resale agreements
For Receivables under resale agreements with remaining period exceeding 1 year, fair value is determined as present future cash flows, discounted by interest rate that would be applied to new acceptance. Total future cash flows are contractual payment of principal and interest. For Receivables under resale agreements with short remaining period (within 1 year), the carrying amount is presented as the fair value, as the fair value approximates such carrying amount. They are classified into Level 2.
 - (3) Monetary claims bought
For monetary claims bought, the carrying amount is presented as the fair value, as the fair value approximates such carrying amount because they have short remaining period (within 1 year). They are classified into Level 2.
 - (4) Trading assets
For securities such as bonds that are held for trading, the fair value is calculated based on their market prices. Japanese Government bonds, etc. are mainly classified into Level 1 and other bonds are classified into Level 2.
 - (5) Securities
For securities such as bonds that are available for sale, the fair value is calculated based on their market prices. Japanese Government bonds, etc. are mainly classified into Level 1 and other bonds are classified into Level 2.
 - (6) Loans and bills discounted
For loans without maturity, the carrying amount is presented as the fair value, as the fair value approximates such carrying amount because of their estimated maturity length and the interest rate conditions. For loans with short remaining period (within 1 year), the carrying amount is presented as the fair value, as the fair value approximates such carrying amount.
For loan with remaining period exceeding 1 year, fair value is determined as present value of total future cash flows, discounted by interest rate that would be applied to newly accepted loans. Total future cash flows are contractual payment of principal and interest.
As for the loans to bankrupt, de facto bankrupt, and potentially bankrupt borrowers, credit loss is estimated based on factors such as the present value of expected future cash flow or the expected amount to be collected from collaterals and guarantees. Since the fair value of these items approximates the carrying amount net of the currently expected credit loss amount, such carrying amount is presented as the fair value. All of the above are classified as Level 3.
 - (7) Foreign exchange
Foreign exchanges consist of foreign currency deposits with other banks (due from other foreign banks), short-term loans involving foreign currencies (due from other foreign banks), export bills etc. (purchased foreign bills), and loans on notes using import bills (foreign bills receivables). For these items, the carrying amount is presented as the fair value, as the fair value approximates such carrying amount because most of these items are deposits without maturity or have short contract term (within 1 year). They are classified into Level 2.
 - (8) Head office and branch accounts
For Head office and branch accounts without maturity, the carrying amount is presented as the fair value, as the fair value approximates such carrying amount. For Head office and branch accounts with maturity, fair value is determined as present value of total future cash flows, discounted by interest rate that would be applied to new transactions. For Head office and branch accounts with short remaining period (within 1 year), the carrying amount is presented as the fair value, as the fair value approximates such carrying amount. They are classified into Level 2.
- (Liabilities)
- (1) Deposits
For demand deposits, the amount payable on demand as of balance sheet date is considered to be the fair value. Time deposits are grouped by certain maturity lengths. The fair value of such deposits is the present value discounted by expected future cash flow. The discount rate is the risk free rates adjusted with funding spread of Citibank, N.A., Tokyo Branch as of balance sheet date. For deposits with short remaining period (within 6 months), the carrying amount is presented as the fair value as the fair value approximates such carrying amount. They are classified into Level 2.
 - (2) Negotiable certificates of deposits
The carrying amount is presented as the fair value, as the fair value approximates such carrying amount. They are classified into Level 2.

(3) Call Money

The carrying amount is presented as the fair value, as the fair value approximates such carrying amount. They are classified into Level 2.

(4) Foreign exchange

Among foreign exchange contracts, foreign currency deposits accepted from other banks and non-resident yen deposits are deposits without maturity. Furthermore, foreign currency short-term borrowing have no maturity. Thus, for the foreign exchanges, the carrying amount is presented as the fair value as the fair value approximates such carrying amount. They are classified into Level 2.

(5) Head office and branch accounts

For Head office and branch accounts without maturity, the carrying amount is presented as the fair value, as the fair value approximates such carrying amount. For Head office and branch accounts with maturity, fair value is determined as present value of total future cash flows, discounted by interest rate that would be applied to new transactions. For Head office and branch accounts with short remaining period (within 1 year), the carrying amount is presented as the fair value, as the fair value approximates such carrying amount. They are classified into Level 2.

(Derivative transactions)

Derivatives include interest rate related instruments (interest rate futures, interest rate options, interest rate swaps, etc.), currency related instruments (forward foreign exchange, currency options, currency swaps, etc.) and bond related instruments (bond futures, bonds future options, etc.). Fair values of these derivatives are based on market prices at exchanges, discounted present values, or amount calculated under the option pricing model. Exchange traded derivative transactions are mainly classified into Level 1. Over-the-counter derivative transactions are classified into Level 2 if observable inputs are available or impact of unobservable inputs to the fair values is not significant. If impact of unobservable inputs to the fair values is significant, they are classified into Level 3.

 - (1) Assignment of duties and the corresponding units in charge are clearly defined, and the system for accomplishment of operation is appropriately established.
 - (2) Internal Audit Division assesses the appropriateness and effectiveness of internal control systems for each responsible unit, and reports the material matters to the Management and Management Committee.
 - (3) All material information concerning Citibank, N.A., Tokyo Branch is adequately reported to the Management and Management Committee as necessary.
