**Citi Appoints Masuo Fukuda as
Citi Japan Vice Chairman and Japan Head of BCMA**

Tokyo -- Citi announced today that it has appointed Masuo Fukuda as Citi Japan Vice Chairman and Japan Head of Banking, Capital Markets and Advisory (BCMA). Effective February 1, 2022, Mr. Fukuda will serve as the Vice Chairman of Citigroup Global Markets Japan Inc. (CGMJ), Citibank, N.A., Tokyo Branch. He will report to Lee Waite, Citi Country Officer for Japan, and matrix report to Tyler Dickson and Manolo Falco, Global Co-Heads of BCMA.

Mr. Fukuda re-joins Citi from Evercore Japan Ltd., where he was Senior Managing Director and President. Prior to Evercore, Fukuda-san was Co-Head of Global Investment Banking at Mizuho Securities, and before that he was Head of Mergers & Acquisitions and Head of Investment Banking at SMBC Nikko Securities Inc., which he joined in 2009 as a result of its partial acquisition of the investment banking businesses from Nikko Citigroup Limited (the predecessor of Citigroup Global Markets Japan Inc.) At Nikko Citigroup, Fukuda-san was the Head of Global Banking and a member of the Executive Committee.

Mr. Fukuda has extensive experience across the full spectrum of investment banking transactions, including mergers and acquisitions and capital markets advisory. He has served as a trusted advisor to several international companies in Japan for many years, leveraging his depth of knowledge, expertise, and client relationship management.
